AS101 – ARCHITECTURAL PLAN

1. The following shall be added to Keynote #1: Patch all exterior and interior finishes to match existing for work related to any doorbell relocation.

AS201 – ARCHITECTURAL DETAILS

1. At detail 11/AS201 the detail call-out labeled x/x shall be labeled: 14/AS201.
