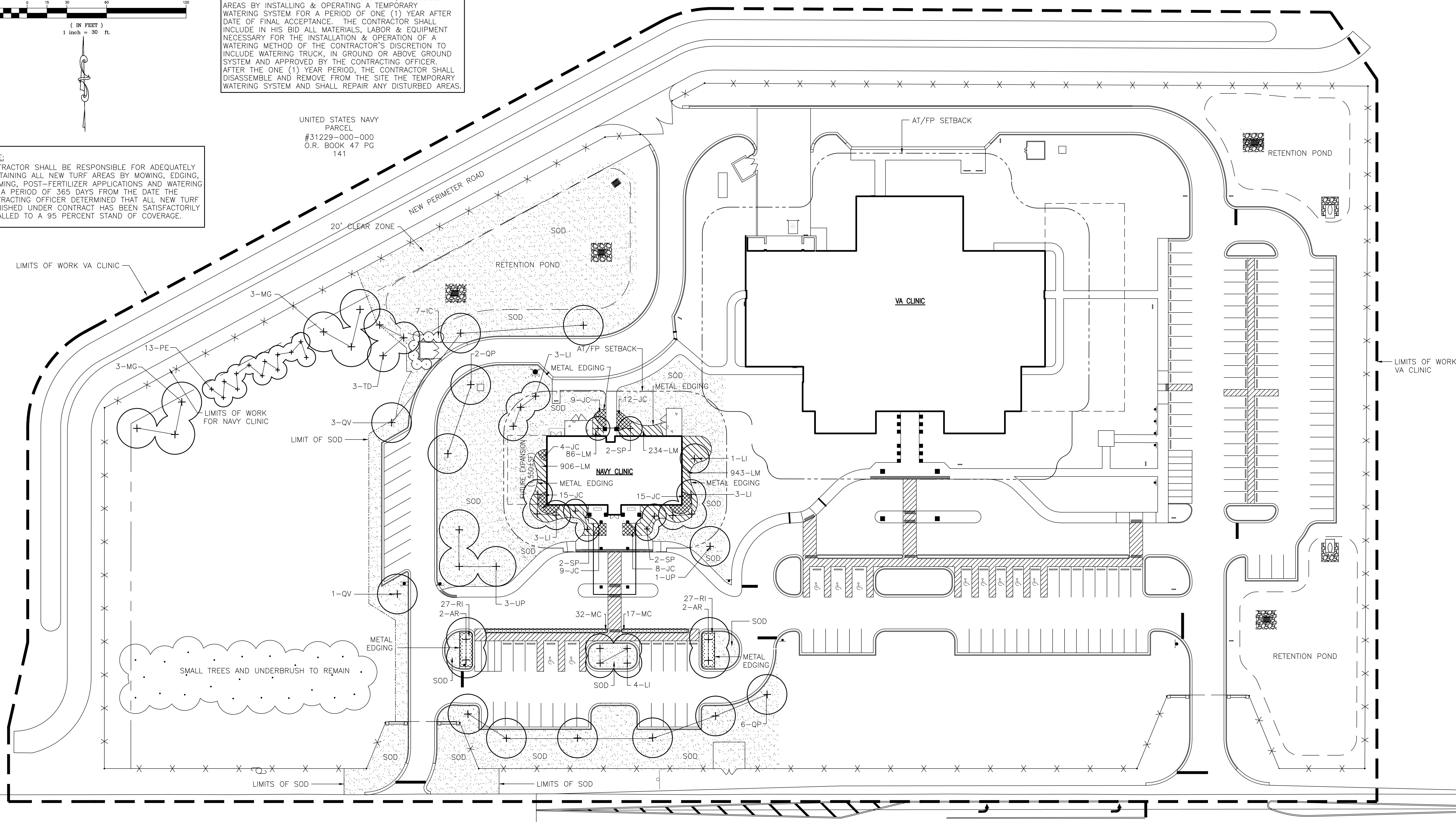


NOTE:
CONTRACTOR SHALL BE RESPONSIBLE FOR ADEQUATELY WATERING ALL NEWLY PLANTED LANDSCAPING, & SODDED AREAS BY INSTALLING & OPERATING A TEMPORARY WATERING SYSTEM FOR A PERIOD OF ONE (1) YEAR AFTER DATE OF FINAL ACCEPTANCE. THE CONTRACTOR SHALL INCLUDE IN HIS BID ALL MATERIALS, LABOR & EQUIPMENT NECESSARY FOR THE INSTALLATION & OPERATION OF A WATERING METHOD OF THE CONTRACTOR'S DISCRETION TO INCLUDE WATERING TRUCK, IN GROUND OR ABOVE GROUND SYSTEM AND APPROVED BY THE CONTRACTING OFFICER. AFTER THE ONE (1) YEAR PERIOD, THE CONTRACTOR SHALL DISASSEMBLE AND REMOVE FROM THE SITE THE TEMPORARY WATERING SYSTEM AND SHALL REPAIR ANY DISTURBED AREAS.
