4. Describe the supply or service to be acquired and the total estimated dollar value: The Clement J. Zablocki VA Medical Center (VAMC) in Milwaukee, WI, has a sole source requirement for Stryker video system equipment.

The total estimated price for this procurement is \$57,269.27.

5. List the proposed contractor (name, contact, and phone number) and describe the unique knowledge or capabilities of the proposed contractor:

The VAMC currently uses Stryker image management and video system equipment in its Operating Rooms (ORs). The facility must procure additional, identical Stryker SDC Ultra Digital Capture equipment to ensure successful interface with all existing Stryker OR equipment. This includes not only the image and video capture medical systems such as Milwaukee VA's million dollar endoscopy equipment inventory, but also the integrated storage database that allows clinical staff to store, review, and share vital procedure playback information. It also interfaces with all video display and printing capabilities within each OR suite. The VAMC must maintain this standardization for full integration of equipment and proper surgical support services. Choosing another vendor's equipment would cripple the OR's medical technology platform. This procurement will mitigate compatibility, maintenance, and other associated costs to the Government.

6. Describe your market research efforts and efforts to ensure that offers are solicited from as many potential sources as is practicable:

Biomedical Engineering at the VAMC conducted thorough market research to include web based research and consultation with vendor(s). Biomedical Engineering has concluded, based upon technical knowledge and the aforementioned market research, that only the


