1. **Contracting Activity:** Department of Veterans Affairs, Network Contracting Office 21 (NCO 21), on behalf of Northern California Health Care System. Procurement request 612-13-3-2973-0100.
2. **Nature and/or Description of the Action Being Processed:** This is a new contract action for firm-fixed-price emergency housing beds, including meals and case management, for homeless Veterans.
3. **Description of Supplies/Services Required to Meet the Agency's Needs:** The VA Northern California Health Care System (VANCHCS) requires contractors to provide services as part of its community based Health Care for Homeless Veterans (HCHV) Contract Emergency Residential Services program. The goal of the HCHV program is to remove homeless Veterans from the street or habitation unfit for Veterans and place them in community-based, residential environments with sufficient supportive services to meet their needs and ultimately, facilitate the improvement of their overall health status and housing situation.

This request will provide five (5) emergency housing beds, including meals and case management, for a period of one year. The period of performance for this requirement is 9/30/2013 – 9/29/2014.



5. **Demonstration that the Contractor's Unique Qualifications or Nature of the Acquisition Requires the Use of the Authority Cited Above (applicability of authority):** The authority cited in section 4 must be used because this contractor is currently providing this emergency housing service to homeless Veterans at their facility. This service consist of room and board to the Veteran, 7 days a week and 24 hours per day; laundry; direct services such as care planning, recovery support, medication management, case management, financial planning, group activities, permanent housing search, discharge planning, and transportation.

Removing the Veterans receiving these services would cause an undue hardship and compromise the Veterans care and treatment.

6. **Description of Efforts Made to ensure that offers are solicited from as many potential sources as deemed practicable:** This requirement will be synopsized in the GPE as required by FAR 5.201, the synopsis will allow other offerors to respond.
7. **Determination by the Contracting Officer that the Anticipated Cost to the Government will be Fair and Reasonable:** The Contracting Officer has determined that the anticipated price will be determined to be fair and reasonable. A Price Negotiation Memorandum (PNM) will detail how the Government has determined that the anticipated costs will be fair and reasonable.
8. **Description of the Market Research Conducted and the Results, or a Statement of the Reasons Market Research Was Not Conducted:** Market research was conducted IAW FAR 10. All indications are that because of the reason stated in section 5, above, only one responsible source and no other suppliers will satisfy agency requirements.
9. **Any Other Facts Supporting the Use of Other than Full and Open Competition:** Any supporting data that is the responsibility of technical or requirements personnel (e.g., verifying the Government's minimum needs or requirements or other rationale for limited sources) and which form a basis for the justification have been certified as complete and accurate by the technical or requirements personnel.
