**4. Describe the supply or service to be acquired and the total estimated dollar value:**

This procurement is for purchase of GI Barrx HALO Flex Radiofrequency Energy Generator. The Barrx HALO Flex Radiofrequency energy generator is able to provide the station with the capacity to perform ablation therapy for the precancerous condition called Barrett's Esophagus. The IGCE for this procurement is \$29,900.00.

**5. List the proposed contractor (name, contact, and phone number) and describe the unique knowledge or capabilities of the proposed contractor:**

No other devices on the market are currently able to provide radiofrequency ablation treatment of Barrett's esophagus. Covidien is the sole manufacturer and distributor of the devices.

**6. Describe your market research efforts and efforts to ensure that offers are solicited from as many potential sources as is practicable:**

It has been determined that the Barrx Flex RFA Energy Generator (by brand name or equal) is not available through a NAC contractor nor a GSA contract. Market research also indicates that Covidien is the sole manufacturer and provider of Barrx Flex RFA Energy Generator and has been confirmed via email.

**7. State why you feel that the anticipated cost to the Government will be fair and reasonable:**

Prices have been determined fair and reasonable in comparison to published price list.

8. Other:

Jesse Brown is currently using HALO. This procurement is an upgrade to existing equipment. HALO technology can be delivered to small areas of the esophagus with HALO90 technology, and to larger areas with HALO360 technology. When first developed, each of these required a different generator so we acquired two separate generators. These have now reached end-of-life. In the meantime, the company has developed the HALO Flex generator which does the job of both types combined into a single unit. This is the most appropriate unit for the Jesse Brown patients, as they can be provided treatment with greater flexibility and efficiency, while utilizing the existing equipment and interchangeable parts already available in inventory.
